- HAVING ACKNOWLEDGED that the new Integrated Plan of Activities and Organization (*Italian acronym: PIAO*) 2024-2026, approved by the Board of Directors in the meeting of 31 January 2024, as a single programming document, provides for a hiring strategy aimed at restoring the balance between the Teacher/Researcher component and that of the technical-administrative staff, already present in the PIAO 2023-2025, keeping in mind that the University's objective is to restore the ratio of 0.97 situation relating to the year 2012), considering all teachers, except Fixed-Ter Researchers (RTD A), and all permanent technical-administrative staff (so-called strategic indicator);
- WITH REFERENCE TO the resolutions of the Board of Directors and the Academic Senate of 13 June, in which the first implementation phase of the planning of the teaching staff and researchers was approved;

Art. 1 Purpose

Four selection procedures by call, for 4 (four) positions of Full Professor, are now open for applications, pursuant to Art. 18, Paragraph 4-ter of Law No. 240/2010, at the University of Camerino, with a single administrative office headquarters, even though several teaching and/or research facilities are located in municipalities other than Camerino, for the below specified Schools, Groups of Academic Disciplines, and Academic Disciplines:

Type of research activity:

The main research activity will consist in the study of the microbiota of insect vectors, with particular attention to the relationships between mosquitoes and yeasts. The overall research activity also includes monitoring analyses of mosquitoes and sandflies in the Umbria-Marche area for the definition of the epidemiological context with reference to arboviruses and their possible control through microbial symbionts.

Type of teaching activity:

The teaching activity includes participation in the teaching of Parasitology (and related subjects) in three-year, master's and single-cycle degree courses in Biology and Veterinary Medicine and supervision of both Bachelor's/Master's degree students and PhD students.

Realisation of the so-called social impact (the so-called third mission):

The third mission activity refers to participation in consolidated activities planned by the University (e.g., Open Houses, Career Days, Science Trips) and to activities related to the dissemination of the results of research developed in its laboratories as per consolidated Open practices Science and Citizen Science.

Assessment of language skills:

Linguistic skills relating to knowledge of the English language will be assessed on the basis of documented curricular experience: therefore, in-person assessment is not envisaged.

Maximum number of publications to be submitted: 12

Type of research activity:

The scientific commitment required must be relevant and impactful both in the field of basic research and in that of applied research, with particular attention to the study and sedimentological and stratigraphic characterization of natural geological reservoirs and the sedimentary tectonic evolution of sedimentary basins. Furthermore, the Teacher will be required to interact with colleagues from other disciplinary areas at a local, national and international level, giving impetus and vigour to basic and applied research activities through the ability to attract public and private funding.



Type of teaching activity:

Based on the training offer provided and the teaching programme, the selected teacher will have to fulfil his teaching commitment at the School of Science and Technology. This commitment will concern teachings relating to the Academic Discipline GEOS-02/B "Stratigraphic geology and sedimentology" (ex-GEO/02), provided in the Bachelor's and Master's degrees, Specialization and PhD courses pertaining to the School of Science and Technology. In particular, the teaching commitment will include courses in Sedimentology and Stratigraphy, Geological Surveying and application subjects in the sector at three-year degree level (Class L-34), and advanced to the Master's degree level (Class LM-74). The Teacher will also have to act as supervisor of degree and PhD theses, participate in final exam committees and in the PhD teaching body, as well as carry out organisational and teaching coordination activities.

Realisation of the so-called social impact (the so-called third mission):

The Teacher's activities in this area will be aimed at the development and implementation of actions aimed at enhancing knowledge, with a cultural and educational impact on citizenship and on the regional, national and international territory. These actions include technology transfer, initiatives in schools and public commitment through the creation of informative publications, participation as an expert in radio and television broadcasts and in public meetings aimed at audiences of non-specialists on relevant topics, such as climate variations, the management of risks and the importance of the conservation and valorisation of natural heritage.

Type of teaching activity:

The required teaching commitment is related to the carrying out of institutional courses relating to the Academic Discipline MEDS-25/A "Forensic Medicine", activated in the three-year and Master's degree courses, as well as PhD and higher-education courses pertaining to the School of Law (masters and training courses), on the basis of the training offered and the educational programming of the relevant courses. In particular, the Teacher will have to impart the teaching activity frontal and via web connection in both semesters of full-time lessons in the subjects referred to in the Academic Discipline MEDS-25/A "Forensic Medicine", and at the same time must guarantee educational participation in the training activities activated by the University.

Only candidates who have obtained the National Scientific Qualification, pursuant to art. 18 paragraph 4-ter of Law No. 240/2010, for the Recruitment field, or for one of the Recruitment Fields included in the same macro-sector and for the positions covered by the procedure, shall be admitted to the selection procedure.

e) Candidates excluded from the active political electorate and those who have been dismissed or released from a position in Public Administration for consistently insufficient performance, or who have been revoked from another public sector position, pursuant to Art. 127, letter d) of Consolidated Law approved by Presidential Decree No. 3 of 10 January 1957.

Art. 4 Application and presentation deadline

Applications for participation in this selection procedure must be submitted within the peremptory term of **30 days**, starting from the day following the date of publication of the relevant Notice in the Official Gazette of the Italian Republic - the 4th Special Series - Competitions and Exams.

Anyone making false statements, uttering forged instruments, or making use of the same, shall be subject to the provisions of Art. 76 of Presidential Decree No. 445/2000.

Acts and documents originally in a foreign language, other than English, French, German r Spanish, must be accompanied by a translation into Italian, certified as conforming to the original, and issued by a competent diplomatic or consular representation, or by an official translator.

Art. 6 Exclusions

All candidates shall be admitted to the procedure conditionally, subject to verification of the aforementioned admission requirements. The Administration, with a reasoned provision, may at any time during the procedure exclude those candidates who do not meet these requirements. The exclusion will be communicated directly to the person concerned at the email address indicated during registration on the platform.

Art. 7 General criteria for the evaluation of candidates

The selection is aimed at identifying the candidates most qualified to carry out teaching and scientific tasks, for which the each position has been opened.

The evaluation takes place on the basis of the criteria, and according to the rules set out by the Selection Committee, in line with the indications of the Notice of Competition.

The criteria take into account the qualifications, scientific publications, curriculum vitae, teaching activity, language skills, if required, and specific competences indicated in Art. 1 of the Notice.

Art. 8 Selection Committee and related obligations

For the purposes of the Procedure by Call, referred to in this Notice of Competition, a Selection Committee shall be appointed, composed according to the provisions of Art. 4 of the Regulations.

Committee members are officially required to participate in the work of the Committee, except in cases of force majeure. The renunciation of the appointment or resignation of a member of the Committee, due to unexpected impediments, must be properly justified, and shall take effect only after the issuance of a Decree of approval by the Rector, also appointing a substitute member.

The Committee shall carry out its work in the presence of all members and shall make any decisions by an absolute majority of the same.

The call for the first meeting of the Committee shall be made by the Rector.

In its first meeting, the Committee shall:

- 1) elect the Chairman and the Minute Taker;
- 2) establish the criteria and the methods for the evaluation of candidates;

At the end of the first meeting, the report containing the criteria and the methods for the evaluation of candidates shall be sent to the Procedure Manager, who must attend to the publication of the same on the University's website, not less than seven (7) days before the continuation of the Committee's work. Each Committee preliminarily verifies possession of the requirements referred to in the art. 3 of this Call, and then proceeds to evaluate the candidate(s) on the basis of the criteria established in the preliminary session.

In all four procedures, the assessment is envisaged without the presence of linguistic skills, according to the methods indicated in the art. 1 of the Call.

At the end of the work, each Selection Committee, after evaluating the candidate(s), carried out on the basis of the scientific publications, curriculum, qualifications, teaching activity and assessment of linguistic skills, with a resolution adopted by a majority of the members, formulates an overall opinion for each candidate, forming a ranking list, and indicating the candidates most qualified to carry out the tasks indicated in the Call.

Once the work is completed, each Committee delivers the competition documents to the person responsible for the proceedings.

The proceedings of the Committee consist of the minutes, drawn up in duplicate copy, of the individual meetings, including the individual, collective and overall judgements expressed on each candidate.

The work of the each Committee must be completed within four (4) months from the publication date of the Rector's Decree concerning the appointment of the Committee in the Official Gazette of the Italian Republic. The Rector may extend the deadline for the conclusion of the procedure for no more than two (2) months, for proven and exceptional circumstances reported by the Chairman of the Committee. In the event that the works are not completed within the set deadline, the Rector, by a substantiated decision, shall initiate the procedure for the substitution of the members responsible for the delay, establishing a new deadline for the conclusion of the works.

Art. 9 **Approval of the Proceedings**

The proceedings must be approved by a Rector's Decree, following the delivery of the minutes by the Committee to the Division of Human Resources, Organisation and Development [Area Persone, Organizzazione e Sviluppo], after verification of their regularity. This Decree shall be communicated to the candidates and to the School publishing the Call, in order to proceed with the subsequent steps. Rector's Decree approving the proceedings shall be published in the Official Gazette of the Italian Republic, and on the website of the University of Camerino.

From the date of publication of the aforementioned Decree in the Official Gazette, the terms for filing any appeals shall start.

The minutes of the meetings and the individual, collective and overall judgments shall be published on the website of the University of Camerino.

In the event of any irregularities, the Rector shall send the proceedings back to the Committee, together with a substantiated decision, establishing a deadline to provide for any necessary changes.

Art. 10 Call

Following the approval of the documents, each School, based on the outcome of the selection, proposes the call of the Full Professor with a favourable vote of the absolute majority of the first-level Professors. This proposal is then submitted to the Board of Directors for approval, subject to verification of the existence of the necessary financial availability and compliance with current regulatory provisions.

Art. 13 Appointment

The appointment to Full Professor is prescribed by Rector's Decree and is subject to verification of the conditions prescribed by laws and regulations on employment and labour.

The candidate proposed for the appointment shall receive a specific communication, inviting him/her to submit the documents necessary for the appointment, under penalty of invalidation.

Art. 14 Processing of Personal Data

Without prejudice to the provisions on publication obligations by Legislative Decree No. 33/2013 and subsequent amendments and the Minerva Code, the University of Camerino undertakes to respect the confidential nature of the information provided by the candidate, pursuant to EU Regulation 2016/679.
